Tabu’s powerful role in ‘Slum Dog: 33 Temple Road Glimpse’

The makers of 'Slum Dog: 33 Temple Road', the upcoming pan-India action drama starring Vijay Sethupathi and directed by Puri Jagannadh, have released a glimpse introducing Tabu as Gowri Hegde, a powerful and fearless officer.

The glimpse opens in the gritty setting of the city's slums before introducing Tabu in a commanding manner. The highlight comes towards the end when she introduces herself as "Gowri Hegde, Deputy Commissioner, Income Tax." The introduction carries the distinctive swagger associated with Puri Jagannadh's character-driven narratives. The glimpse also features brief shots of Vijay Sethupathi.

Tabu brings intensity and authority to the role, making Gowri Hegde one of the film's intriguing characters. Samyuktha plays the female lead, while Duniya Vijay appears in a negative-shaded role. Brahmaji and VTV Ganesh are also part of the cast.
