21 killed in 24 hours as flood situation worsens in Assam

GUWAHATI

The flood situation in Assam further deteriorated on Tuesday as 21 more persons died, while 5.64 lakh people were affected across 16 districts, an official bulletin said.

According to a late-night bulletin issued by the Assam State Disaster Management Authority (ASDMA), the worst-hit Sivasagar district reported 13 fatalities in the last 24 hours, followed by five deaths in Charaideo, two in Golaghat and one in Jorhat.

With these deaths, the toll in this year's flood in the state rose to 31.

Chief Minister Himanta Biswa Sarma said he would visit the worst-affected districts from Wednesday to review the relief and rescue operations.

"The recent #AssamFloods, caused by the cloudburst upstream, have brought immense hardship to our people. Tomorrow I will be visiting flood-affected areas and relief camps in Charaideo, Nazira, Sivasagar,

Rain batters Kangra, three injured
KangraShimla/Dharamshala: Three persons were injured, and 12 more houses were damaged in the Boh Valley of Himachal Pradesh's Kangra district amid overnight rain, officials said on Wednesday.

Sonari, Jorhat and Teok to review the relief operations," he said in a social media post.

The ASDMA said over 5.64,600 people in Golaghat, Kamrup, Hojai, Dibrugarh, Bishwanath, Dhemaji, Sonitpur, Udaiguri, Nagaon, Charaideo, Kamrup (Metro), Jorhat, Tinsukia, Karbi Anglong, Lakhimpur and Sivasagar have been affected by the deluge, up from over 3.63 lakh people in 15 districts on Monday.

The bulletin said 872 villages across 44 revenue circles remained inundated.

A total of 3,59,535 people were affected in Sivasagar, followed by 87,662 in Jorhat and 72,646 in

Rajouri/Jammu: Jammu and Kashmir Deputy Chief Minister Surinder Choudhary and National Conference MP Mian Altaf escaped unhurt in two separate mudslide incidents along the Jammu-Poonch National Highway amid incessant rains on Wednesday, officials said.

Charaideo, it said.

Seventy-one relief camps, housing 12,284 displaced people, and 202 relief distribution centres are currently operational, the bulletin said.

The Dikhou and Disang rivers were flowing above the highest flood level at Sivasagar town and Nanglamuraghat, both in Sivasagar district. The Brahmaputra at Nematighat, Burhidihing at Khowang, and Dhansiri (South) at Golaghat and Numaligarh were flowing above the danger mark.

Sibal seeks SC review of merger provision

NEW DELHI

Senior Advocate Kapil Sibal has moved the Supreme Court by filing a writ petition as a party-in-person challenging the interpretation of the Tenth Schedule to the Constitution, contending that the existing legal position on political mergers is diluting the anti-defection law.

The petition, filed against the Union of India, was assigned Diary No. 42846/2026 and filed on July 20, according to details available on the apex court's official website.

Appearing before a Bench headed by Chief Justice of India (CJI) Surya Kant, Sibal mentioned the matter and sought an early hearing.

Addressing the CJI Kant-led Bench, Sibal said: "I have filed a petition in person. It relates to the issue of whether the composition of the Parliament can change in the fashion in which it is happening in this country and the interpretation of the Tenth Schedule, Paragraph 4, in that context."

Expressing concern over recent political developments, Sibal submitted that if the present trend continued, the anti-defection law under the Tenth Schedule would be rendered ineffective.

"What is happening in this country? If this continues, the Tenth Schedule will become meaningless," he said, adding that a similar matter

SC asks AIIMS for Asaram's medical report PTI

The Supreme Court on Tuesday asked the director of AIIMS to constitute a medical board to assess the condition of self-styled godman Asaram, who has sought interim bail on medical grounds.

The Rajasthan High Court on May 27 upheld the conviction and life sentence awarded to the octogenarian in a case of rape of a minor in 2013.

A bench of justices M M Sundresh and P B Varale asked the medical board to submit its report within a week.

During the hearing, Solicitor General Tushar Mehta submitted that just three months ago Asaram undertook journeys to Kashi Vishwanath and Ayodhya, though claiming that he was in a vegetative state.

आरोपी ने शादी से साफ इनकार कर दिया- पीडिता का आरोप है कि जब उसने शादी की बात की तो आरोपी ने फ्लोटो और वीडियो वायरल करने की धमकी देकर उसे डराया। इसी धमकी के बल पर वह लगातार उसका शोषा 1 करता रहा। पीडिता के अनुसार 5 जनवरी को आरोपी के दोस्त के घर दोनों के बीच शादी को लेकर विवाद हुआ, जहां आरोपी ने शादी से साफ इनकार कर दिया और बदनाम करने की धमकी दी। इसके बाद 3 जुलाई को भी उसने फोन कर युवती को बुलाने और धमकीयों की कोशिश की। लगातार प्रताड़ना से परेशान होकर पीडिता ने पूरी घटना अपने परिजनो को बताई। मंगलवार को परिजन उसके साथ हैरानगर थाने पहुंचे, जहां आरोपी के खिलाफ दुष्कर्म का मामला दर्ज कराया गया। पुलिस ने मामला दर्ज करने के बाद टेराट आरोपी हर्ष उर्फ राज चौहन को गिरफ्तार कर लिया। मामले की जांच जारी है।

बोले- छात्रों को कीड़े और आंदोलन को प्रायोजित क्यों कहा, पुलिस जबरन उठा ले गई

इंदौर,(नप्र)। नगरीय विकास एवं आवास मंत्री कैलाश विजयवर्गीय के घर के सामने बुधवार को दंपती ने प्रदर्शन किया। वे सविधान की कापी लेकर गेट के सामने खड़े हो गए। उनका कहना था कि विजयवर्गीय के हाल ही में दिए बयानों से वे आहत हैं।

उनकी पत्नी संगीता पाण्डेय को भी साथ लेकर थाने ले गए।

सांसद लालवानी के घर पर भी कर चुके नारेबाजी- टीआई आरडी कानवा ने बताया कि दंपती बिना अनुमति के प्रदर्शन करने पहुंचे थे। माहौल बिगड़ने की आशंका को देखते हुए उन्हें पूछताछ के लिए अभिरक्षा में लिया गया है। आगे की कार्रवाई जांच के आधार पर की जाएगी। इससे पहले पाण्डेय दंपती सोमवार को सांसद शंकर लालवानी के घर पर भी प्रदर्शन और नारेबाजी कर चुके हैं। वे केंद्रीय मंत्री धर्मेंद्र प्रधान के इस्तीफे की मांग कर रहे थे।

पानीपुरी के पैसे को लेकर दोस्तों में विवाद

दो युवकों पर चाकू से हमला, एक की हालत गंभीर, आरोपी को हिरासत में लिया

इंदौर,(नप्र)। हीरानगर थाना क्षेत्र में पानीपुरी खाने के बाद पैसे देने की बात पर हुए विवाद में दो दोस्तों ने अपने ही दो साथियों पर चाकू से हमला कर दिया। हमले में एक युवक गंभीर रूप से घायल हो गया, जबकि दूसरे को प्राथमिक उपचार के बाद अस्पताल से छुट्टी दे दी गई। पुलिस ने दोनों आरोपियों को हिरासत में ले लिया है।

पुलिस के मुताबिक मंगलवार रात सुखलिया क्षेत्र से चाकूबाजी की सूचना मिली थी। घटना में वीरेंद्र पुत्र दरबार सिंह निवासी सुखलिया और अर्जुन पुत्र संतोष निवासी राय बंगला घायल हुए थे।

पुलिस जांच में सामने आया कि चारों युवक आपस में दोस्त हैं।



घायल अर्जुन ने पुलिस को बताया कि वह, वीरेंद्र, सोकेस उर्फ शोकेस पुत्र अशोक निकुम निवासी साई पैलेस कॉलोनी और सौरभ पुत्र राजेश कुमार खटीक साथ में पानीपुरी खाने गए थे।

इसी दौरान पानीपुरी के पैसे चुकाने को लेकर सोकेस और वीरेंद्र के बीच कहासुनी हो गई। विवाद बढ़ने पर सोकेस ने चाकू निकालकर वीरेंद्र के पेट में वार कर

दिया। बीच-बचाव करने पहुंचे अर्जुन को भी चाकू लग गया।

एक युवक आईसीयू में मर्ती

हमले में वीरेंद्र गंभीर रूप से घायल हुआ है। पेट में चाकू लगने के कारण उसे अस्पताल के आईसीयू में भर्ती कराया गया है। वहीं अर्जुन का उपचार के बाद अस्पताल से छुट्टी दे दी गई। घटना के बाद दोनों आरोपी मौके से फरार हो गए थे, लेकिन पुलिस ने रात में ही दबिश देकर दोनों को हिरासत में ले लिया। मामले में आगे की कार्रवाई की जा रही है।

गीता विहार कॉलोनी के डायरेक्टर सहित अन्य पर केस

इंदौर,(नप्र)। देपालपुर की गीता विहार कॉलोनी में बंधक रखे गए प्लॉटों की बिक्री कर खरीदारों से कथित धोखाधड़ी करने के मामले में एडह ने एस.एस.सी. इन्फ्रा एस्टेट प्राइवेट लिमिटेड के डायरेक्टर, आम मुख्तारगारी और अन्य के खिलाफ धोखाधड़ी का केस दर्ज किया है। जांच में सामने आया बेच दिया गया।

ईओडब्ल्यू की जांच के अनुसार ग्राम ताजखेड़ी (तहसील देपालपुर) स्थित गीता विहार कॉलोनी के विकास काम के लिए प्लॉट क्रमांक 88, 89, 90 और 124 को कॉलोनी सेल के माध्यम से बंधक रखा गया था। बावजूद इसके मार्च और मई 2018 में इन प्लॉटों का 55.80 लाख रूप में बेच दिया गया, जबकि किक्रिताओं को इन प्लॉटों पर स्वामित्व हस्तांतरण का अधिकार ही प्राप्त नहीं था।

70 प्रतिशत काम ही पूरा हुआ था- शिकायत भ्रष्टाचार विरोधी संगठन के सचिव एस. शिवम ने की थी। शिकायत में आरोप लगाया गया था कि कॉलोनी का विकास काम पूरा हुए बिना फर्जी इंजीनियर प्रमाण-पत्र तैयार कर ररा में प्रस्तुत किया गया और शासन के पास बंधक प्लॉटों का भी बेच दिया गया।
